Scholarship Program

The goal of our program is to provide community members with support and resources to achieve their educational endeavors.

GRIC Scholarship Covers

- Educational expenses: tuition and books
- Living expenses: room/board, personal, and transportation
- Exact amount of funding is determined by the school's financial aid office based on the cost of attendance
- GRIC Student Services only pays for the unmet need

Eligibility Requirements

- Must be an enrolled member of the Gila River Indian Community
- Must have a High School Diploma or Graduation Equivalency Diploma (GED)
- Must be accepted to an accredited college or university
- Must complete a Free Application for Federal Student Aid (FAFSA)

Length of Program Funding

Undergraduate: 12 semesters or 18 quarters

Graduate: 12 semesters or 18 quarters

Doctorate: 16 semesters or 24 quarters

Important Dates For New Students

- Applications due for Fall Term - June 1st
- Applications due for Spring Term - November 1st
(Note: we accept early applications)
- Applications due for approved Vocational and Trade Schools -
Two months prior to start date



Gila River Indian Community **APPLICATION PROCESS**

- 1** Applicant submits application materials to Student Services by indicated deadline.
- 2** Student Advisor reviews application material and gives applicant a check sheet showing what has been submitted.
- 3** Student Services sends approval or denial letter to applicant within four (4) weeks after the deadline date.
- 4** Approved applicants must attend mandatory Student Services Orientation.
- 5** Student Services sends Financial Needs Analysis (FNA) to school to be filled out by their Financial Aid Office.
